The undersigned do(es) hereby give permission for our (my) child(ren): _____

LIABILITY RELEASE: In consideration of **Truth in Nature, Inc.** allowing the Participant(s) to participate in outdoor ministry activities, I (we), the undersigned, do hereby release, forever discharge and agree to hold harmless **Truth in Nature, Inc.**, its directors, employees, volunteers and agents (collectively sometimes referred to herein as the "Organization") from any and all liability, claims or demands for accidental personal injury, sickness or death, as well as property damage and expenses, of any nature whatsoever which may be incurred by the undersigned and the Participant while involved in the children/youth activities. I (we), the parent(s) or legal guardian(s) of this participant or these participants, hereby grant my (our) permission for the Participant(s) to participate fully in outdoor ministry activities at all Truth in Nature, Inc. venues.

Furthermore, I (we), on behalf of my (our) minor Participant(s) hereby assume all risk of accidental personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein.

Further, authorization and permission is hereby given to said Organization to furnish any necessary transportation (within the limitations of organization insurance and the law), food and lodging for this Participant or these participants. The undersigned further hereby agree to hold harmless and indemnify said Organization for any liability sustained by said Organization as the result of the negligent, willful or intentional acts of said Participant(s), including expenses incurred attendant thereto.

Further, I (we) give authorization and am fully aware that the student(s)/participant(s) named above may be participating in Truth in Nature, Inc. activities in which I (we) and/or the participant(s) named above may be photographed or videotaped from time to time. Such images produced, wherein the likeness of my (our) child or children appear, shall be referred to hereinafter as "Property". I (we) hereby irrevocably grant to Truth in Nature, Inc. perpetually, exclusively, for all media (including print, nontheatrical, home video, CDROM, internet and any other electronic medium presently in existence or invented in the future), the right to use and incorporate (alone or together with other materials), in whole or in part, photographs, sound bites or video footage taken as a result of my child or children's participation in Truth in Nature, Inc. activities. I (we) hereby agree that I (we) will not bring or consent to others bringing a claim or action against Truth in Nature, Inc. on the grounds that anything contained in the "Property", or in the advertising and publicity used in connection herewith, is defamatory, reflects adversely on me (us) or the student(s)/participant(s) named above, or violates any other rights whatsoever, including, without limitation, rights of privacy and publicity. I hereby release Truth in Nature Inc., its owners, members, and all employees and agents of these parties from and against any and all claims, demands, actions, causes of actions, suits, costs, expenses, liabilities, and damages whatsoever that I may hereafter have against Truth in Nature Inc. in connection with the "Property". This agreement shall not obligate Truth in Nature Inc. to use the "Property" or to use any of the rights granted hereunder, or to prepare, produce, exhibit, distribute or exploit the "Property". Truth in Nature, Inc. shall have the right to assign its rights hereunder, without my (our) consent, in whole or in part, to any person, firm, corporation or organization.

I further covenant and agree not to sue any of the Released Parties for any of the claims that I have waived, released, or discharged herein.

I agree to indemnify and hold harmless Truth in Nature, Inc. from any and all expenses incurred, claims made, or liabilities assessed against them, including but not limited to attorneys' fees and litigation expenses, arising out of or resulting from, directly or indirectly, in whole or in part, my (our) breach or failure to abide by any part of this Release document, and my (our) actions or inactions which cause injury or damage to any other person.

MEDICAL TREATMENT PERMISSION: I (we), authorize an adult, in whose care the minor has been entrusted, to consent to any emergency x-ray examination, anesthetic, medical, surgical or dental diagnosis or treatment and hospital care, to be rendered to the minor under the general or special supervision and on the advice of any physician or dentist licensed under the provisions of the Georgia Medical Practice Act on the medical staff of a licensed hospital or emergency care facility. The undersigned shall be liable and agree(s) to pay all costs and expenses incurred in connection with such medical and dental services rendered to the aforementioned child or children pursuant to this authorization.

EARLY RETURN HOME POLICY: Should it be necessary for my (our) child or children to return home due to medical reasons, disciplinary action or otherwise, the undersigned shall assume all transportation costs and responsibility.

TRANSPORTATION PERMISSION: The undersigned does also hereby give permission for my (our) child or children to ride in any vehicle driven by an approved ADULT chaperone while attending and participating in activities sponsored by **Truth in Nature, Inc.** My child or children and I understand that SEAT BELTS SHALL BE WORN AT ALL TIMES during transportation.

USE OF EQUIPMENT PERMISSION: I (we) authorize and give permission for my (our) child or children to use any and all equipment, after the organization's safety courses have been taken, for activities (hunting, fishing, camping) including but not limited to firearms, ammunition, fishing rods/reels, hooks, tents, hand tools, knives, and camping supplies.
